# COURT SOCIAL WORK SERVICE

## 宗旨

法院社工服務透過專業社工向在本港被檢控的候審人士及其家人提供輔導及有關幫助，以減輕他們在審訊過程中所面對的壓力和焦慮。此外，本服務亦為被判刑的人士，特別是無需入獄者提供善後輔導，以加強他們奉公守法的意識。

## Objective

The service aims to render support to individuals in conflict with the law at the pre-sentence stage, to help them and their families alleviate stresses and anxieties associated with the court procedures. Follow up counseling and other social services are also provided, in particular to non-custodial offenders requesting assistance.

## 服務對象

## 服務範圍

### 法院社工外展服務

透過社工定期到本港各裁判法院，主動接觸及協助候審人士解決因面對司法程序而產生的有關問題，例如不認識法律程序，面對刑罰所衍生的焦慮不安等。

### 輔導工作

因應服務使用者的問題，如家庭、情緒、行為、經濟及就業等問題，提供輔導服務。

### 義工服務

本服務安排受訓義工定期到法院，協助推行服務，使更多服務對象受惠。

### 轉介服務

因應服務使用者的需要而轉介往其他有關機構，如社會福利署，法律援助署等接受服務。

## Service Target

People in conflict with the law of Hong Kong Special Administrative Region (HKSAR) and their family members.

## Scope of Service

### Outreaching Social Work Service

Professional social workers station at designated magistracies to provide services to individuals who are attending courts and to help them solve problems related to the offence or to release anxieties arising from possible sentences.

### Counselling Service

Counselling Service is provided to help service users solve problems relating to family, emotion, finance, behavior and employment.

## Volunteer Service

Trained volunteers visit the magistracies regularly to facilitate service delivery.

## Referral Service

If further assistance is required, social workers will refer service users to other organizations in accordance with their needs. For examples, to Social Welfare Department and Legal Aid Department, ect.

## Fee Charging

Free of charge
